
Special Town Meeting Warrant

TOWN OF CLINTON COMMONWEALTH OF MASSACHUSETTS

WARRANT FOR SPECIAL TOWN MEETING

WORCESTER, SS.

To the Constables of the Town of Clinton in the County of Worcester.

GREETINGS:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of the Town, qualified to vote in the elections and town affairs, to meet at the Town Hall in said Clinton on Monday, the fifth day of June 2017 at 7:00 P.M., then and there to act on the following articles:

ARTICLE 1

To see if the Town will vote to raise and appropriate and transfer from the Ambulance Enterprise Fund Retained Earnings the amount of \$6,000.00, or any other sum, said sum to increase the Fiscal Year 2017 Ambulance Enterprise Fund Overtime Line-Item from \$19,000.00 to \$23,000.00, or act in any manner relating thereto.

(Finance Committee - Approved)

ARTICLE 2

To see if the Town will vote to raise and appropriate and transfer from the Water/Sewer Enterprise Fund Retained Earnings the amount of \$300,000.00, or any other sum, said sum to increase the Fiscal Year 2017 Water/Sewer Improvements Line-Item from \$28,000.00 to \$328,000.00, or act in any manner relating thereto.

ARTICLE 3

To see if the Town will vote to establish a Project Reserve Account in the Landfill Enterprise Fund and to raise and appropriate and transfer from the Landfill Enterprise Fund Retained Earnings the amount of \$3,600,000.00, or any other sum, to said Project Reserve Account for Fiscal Year 2017, or act in any manner relating thereto.

ARTICLE 4

To see if the Town will vote to transfer from the Stabilization Fund or take from available funds a sum of money to be expended by the Police Department to fund retroactive wages as part of a negotiated agreement between the Town of Clinton, through the Board of Selectmen, and the Massachusetts Coalition of Police – Local 151 for the period July 1, 2014 to June 30, 2017, having been negotiated in accordance with M.G.L. Chapter 150E, as amended, or act in any manner relating thereto.

ARTICLE 5

To see if the Town will vote to transfer from the Stabilization Fund or take from available funds a sum of money to be expended by the Fire Department to fund retroactive wages as part of a negotiated agreement between the Town of Clinton, through the Board of Selectmen, and the International Association of Fire Fighters – Local 3189 for the period July 1, 2014 to June 30, 2017, having been negotiated in accordance with M.G.L. Chapter 150E, as amended, or act in any manner relating thereto.

ARTICLE 6

To see if the Town will vote to supplement each prior vote of the Town that authorizes the borrowing of money to pay costs of capital projects to provide that, in accordance with Chapter 44, Section 20 of the General Laws, the premium received by the Town upon the sale of any bonds or notes thereunder, less any such premium applied to the payment of the costs of issuance of such bond or notes, may be applied to pay project costs and the amount authorized to be borrowed for each such project shall be reduced by the amount of any such premium so applied, or act in any manner relating thereto.

ARTICLE 7

To see if the Town will vote to accept the provisions of Massachusetts General Laws Chapter 71, Section 71F, as amended, to provide for the education of non-resident or foster care students, or act in any manner relating thereto.

HEREOF FAIL NOT, and make due return of this warrant with your doing thereon, to the Town Clerk, at the time and place of the meeting, as aforesaid.
