

# TRASH & RECYCLING COLLECTION REGULATIONS\*

*Property Owners – Please Share This Information With All Tenants*

## SINGLE FAMILY RESIDENCE – This “S” Sticker is on your Recycle bin

- The Town charges a monthly fee of \$14.00 per month for each SINGLE FAMILY RESIDENCE.
- **The fee includes 1 trash bag per week – no trash sticker required.**
- **ONE Trash sticker is required for each ADDITIONAL bag of trash at the curb.**



## MULTI FAMILY RESIDENCE - This “M” Sticker is on your Recycle bin

- The Town charges a monthly fee of \$11.00 per month for each MULTI FAMILY PROPERTY.
- **ALL TRASH BAGS ARE REQUIRED TO HAVE ONE TRASH STICKER ATTACHED.**
- **All Apartments in a Multi Family property must attached 1 Trash Sticker to ALL Trash Bags**



## RECYCLE BIN

- Each residential property is supplied with **ONE** green recycling bin.
- Multi-family property owners only can request additional bins if required.
- There is NO CHARGE for the recycling bins(s).
- The Town will deliver the bins(s) to your property.



## TRASH BAG WEIGHT LIMIT, DROP OFF RECYCLE CENTER

- **Each Trash Bag MUST be 25 Pounds or less. Bags over the weight limit will NOT be picked up.**
- Place the Trash Sticker in a visible location on the bag. Any trash bag may be used.
- Curbside trash pickup is EVERY week and recycling pick up is EVERY OTHER week.
- Leaves, yard waste, bulky items and construction debris are NOT accepted at the curb.
- Drop-Off Recycle Center at (99 Woodlawn Street) accepts leaves & yard waste year round for free; many items including (furniture, appliances, mattresses, electronics, carpet, etc.) are accepted for a fee.

## TRASH STICKERS

- Trash Stickers can be purchased for \$2.50 each at: Tax Collector’s office at Town Hall, Shaw’s, Hannaford’s, and many convenience stores in Clinton. Subject to availability at stores, refer to the store location list.

## OPT-OUT & OPT-IN

- Residents are allowed to “Opt-Out” of the program for any reason.
- If you opt-out the Town WILL NOT pick up curbside recycling OR trash bags at your property.
- Multi-Family properties may opt out for the entire property, units will not be allowed to opt out individually.

## BILLING

- The monthly fee is added to your Quarterly Water Bill as a SEPARATE charge.
- On each Quarterly Water/Sewer Bill there is a fee for 3 months of collection service.
- Contact the Assessor’s Office at 978-365-4117 to determine if you qualify for a personal exemption; to receive a reduced monthly fee, you must be over 70 years old and be financially qualified.
- Contact the Veteran’s Office at 978-365-4112 to determine if you qualify for a veteran’s exemption, this applies to owners of single family properties only.
